APRIL 11, 2024 OZARK FOOTHILLS REGIONAL PLANNING COMMISSION

OZARK FOOTHILLS RPC, POPLAR BLUFF, MISSOURI

I. Call to Order

Chairman Brian Polk called the meeting to order at 6:08 p.m.

II. Open for Public Discussion

No public discussion ensued.

III. Adoption of January 11, 2024 Minutes

The minutes of the January 11, 2024 TAC meeting were reviewed. The minutes were adopted on a motion by Jesse Roy, Ripley County, and second by Dennis Cox, Ripley County.

IV. Missouri Department of Transportation Reports

Tammy Hefner, MoDOT Southeast District, announced that she had taken the position of Assistant District Engineer previously held by Chris Rutledge. Currently, the Executive Team at MoDOT is finalizing the Draft Statewide Transportation Improvement Plan (STIP). The public comment period for the plan is expected to open in June. State legislators are looking at additional funding for the Highway 67 South corridor. The City of Poplar Bluff is working with MoDOT on the Cost Share to try to have a letting in September for part of the project.

Matt Wilkerson, MoDOT Southeast District, reviewed a handout covering updates, past lettings, work zones, and cost share information. Scrub seals in Wayne County on MO 34 and MO 143 were let in January alongside Route AA in both Reynolds and Wayne Counties. Route B in Carter County also had a bridge replacement awarded over Ten Mile Creek. Route U in Butler County and Route B in Reynolds County were awarded in March for a bridge deck replacement and bridge replacement respectively. The Next application deadline for the Cost Share Program is July 19, 2024.

Elquin Auala, MoDOT Southeast District, announced Melissa Rose is the new LPA Contact for the Southeast District. She was unable to attend the meeting due to a prior training. MoDOT TAP applications are due by April 26th. If the project is on MoDOT ROW, the deadline has passed for the area engineer to provide a letter of approval. Projects entirely on local right of way still have time to be submitted. BRO applications will most likely be taken in October. The lists of eligible bridges are available on the website, or reach out to Melissa, Matt or her.

Mike Brandon, MoDOT Southeast District, stated the district is currently working on the Unfunded Needs List and will let everyone know when a draft is available. The STIP was impacted a lot by inflation and only one project is moving from the Unfunded Needs List to the STIP in the upcoming draft. Only about half of resurfacing and bridge projects were added to the STIP as originally planned as inflation is increasing costs. It looks like higher prices are here to stay. Projects will still move off of lists, but it may be slower than the last few years. A public meeting will held in the mid-July to mid-August range for the Unfunded Needs List and will most likely occur in Perryville.

Joe Killian, MoDOT Southeast District, said if any counties have questions about the county road inventory please reach out and he will be happy to address those questions. He was able to speak to a couple of counties tonight. Every county in Missouri has a map available on the MoDOT website. Some aren't as up to date as others, but every county is listed. Mr. Killian stated that if any cities have changed boundaries through annexation, and has geospatial data showing the new boundaries, MoDOT would be able to apply the data in updating maps.

V. Transportation Planning Coordinator Report

Mr. Murphy announced Butler County submitted a RAISE application to the FHWA for Butler County Road 321 for paving, widening, drainage, etc. estimated at \$5,811,141. The roadway connects Highway 142 with an outer road off of the current Highway 67 and future I-57 and is traveled heavily by large trucks.

The Ozark Foothills RPC submitted a request to the Safe Streets for All (SS4A) Planning grant to write a Comprehensive Safety Action Plan for the 5-county region that would include input from all 16 incorporated cities. Some federal grants are now requiring cities and counties to have a comprehensive safety action plan on file to receive certain implementation grants from the USDOT. This plan, should it be awarded, and once completed after 2 years, would make all 16 cities and 5 counties eligible.

Action Plans are comprehensive safety plans aimed at reducing and eliminating serious-injury and fatal crashes affecting all roadway users. The OFRPC proposed a 20-year plan that would cover the area through 2046 or 2047 depending on award date and requested funding of \$116,000.

The 2024 Delta Regional Authority (DRA) SEDAP Application Cycle opened in March 2024 and closes summer 2024. DRA's focus is on Transportation Infrastructure, Basic Public Infrastructure, Healthcare, Workforce Development, and Small Business and Entrepreneurship. Tier 1 projects must meet each of the following three federal priorities, as outlined in the Eligibility Guidelines: 1) job creation and/or retention utilizing a participation agreement, 2) include other sources of public and/or private funds, and 3) have a regional impact. Each state will be required to spend 50 percent of the state allocation on Tier 1 projects, before recommending Tier 2 projects for funding. Tier 2 projects will encompass all other eligible projects.

DRA's Critical Infrastructure Fund (CIF) applications are open as well. The CIF looks to make investments that support projects that address flood control, basic public infrastructure, and transportation infrastructure improvements. The applications are accepted on a rolling basis and projects are competitive in the entire DRA region. Projects can request up to \$2 million.

The OFRPC is working on one CIF application for the City of Poplar Bluff to repair Butzen Drive and Harlo Dunn roads, plus the intersection at Butzen and Rowe Parkway. A final cost estimate is all that remains for this project.

MoDOT's Transportation Alternative Program (TAP) applications are being accepted with an April 26th due date. The program requires a 20% cash match. The City of Poplar Bluff is submitting an application for a pedestrian crosswalk, flashing signal, and sidewalk to connect the existing sidewalk at the Poplar Bluff Housing Authority across US Highway 60 to Linc Park on the east side of Poplar Bluff. The City of Ellington is looking into applying to the program as well.

Mr. Murphy announced that MoDOT has requested an RPC and TAC representative to serve on the 2024 Transportation Alternative Program selection committee. The deadline to submit the names of the RPC and TAC representative is April 30th, with a virtual meeting planned for May 7th for pre-scoring and receipt of applications, submission of scoring due by May 21st, and an in person meeting to score and select awardees on May 23rd. The previously identified BRO scoring committee agreed to score the TAP applications and a volunteer will to attend the meeting will be sought prior to April 30th.

The Community Development Block Grant rounds for FY23 and FY24 opened on April 8, 2024 and have a September 6, 2024 due date. For the general infrastructure category, paving, drainage, sidewalks, pedestrian bridges, etc. are eligible expenses. Projects will have a \$500,000 max award request with engineering fees, inspection, and grant administration on top of the \$500,000. Conversations have been held with Butler County, Fisk, Qulin, Neelyville, Greenville, Doniphan, Naylor, Bunker and Ellington so far regarding paving projects.

Joint TAC/County Commission meetings were held in March to allow an opportunity for members of the public to meet with their local TAC members and provide feedback regarding the prioritization process.

Mr. Murphy spoke regarding the Missouri Coalition for Roadway Safety. The Coalition is a partnership of safety advocates throughout the state who have come together for a common purpose: to end traffic fatalities and serious injuries on public roadways. Each MoDOT district has its own Coalition. They are currently meeting in a hybrid style in Sikeston on the 2nd Tuesday at 10am and the 2nd Wednesday in West Plains or Mountain Grove at 10 am. This month however, they are meeting on the 3rd Tuesday. The coalition is involved with Project Prom funding to local high schools, the Buckle Up Phone Down signs, which are available upon request, various informational and branded items, Battle of the Belt challenges, etc.

VI. Old Business

No old business to discuss.

VII. New Business

Mr. Murphy spoke covering Active Transportation Plan (ATP) development in the region. An Active Transportation Plan is a comprehensive resource that documents existing conditions and guides the planning, design, implementation, and evaluation of bicycle and pedestrian programs, policies, guidelines, and infrastructure improvements. Back in December 2023, representatives

from MO DHSS and the University of Missouri-Columbia met with 5 regional planning commissions and MoDOT regarding funding to pay the RPCs to complete Active Transportation Plans in counties that DHSS and Mizzou received grants from Centers for Disease Control. Grants were awarded to DHSS and Mizzou for counties that met certain criteria. Butler County is included in the DHSS State Physical Activity and Nutrition (SPAN) grant and Ripley and Wayne Counties are included in the University of Missouri High Obesity Program (HOP) grant.

MO DHSS is in the process of contracting with the OFRPC to write three Active Transportation Plans over the next three years beginning October 1, 2024 and ending September 30, 2027. The OFRPC is also writing an ATP for the City of Poplar Bluff through a grant from the Butler County Health Department. This plan will be completed by December 2024 and will be the first Active Transportation Plan in the region.

After discussion, each county submitted the county-wide priorities for projects, maintenance, and multi-modal needs. See attached list below.
