The Ozark Foothills Regional Planning Commission (OFRPC) manages its internal activities, as well as the activities of the Ozark Foothills Development Association, the Ozark Foothills Regional Community Foundation, the Ozark Foothills Solid Waste Management District, and the Ripley County Public Housing Agency.

The OFRPC's core service is providing grant preparation and administrative services to its five member counties & sixteen member cities.

During Fiscal Year 2021, OFRPC staff prepared 60 grant applications and brought **\$8,679,404** into the Ozark Foothills Region.

# Ozark Foothills Development Association, Inc.

The Ozark Foothills Development Association is an IRS-defined non-profit charged with enhancing economic development in the five-county region. The association administers the Ozark Foothills Business Incubator.

The Small Business Incubator, constructed in 1988 and expanded in 2018, provides 30,000 square feet of affordable operating space to start-up or expanding enterprises.

During FY 2021, the Ozark Foothills Development Association maintained 100% occupancy within its original incubator and 75% within the expansion area.

One of the four newly constructed spaces are vacant.

## **Ozark Foothills Regional Community Foundation**

The Ozark Foothills Regional Community Foundation, established November 2011, is the charitable arm of the Ozark Foothills Regional Planning Commission. The mission of the Foundation is to establish endowments that enhance the quality of life for current and future generations by reinvesting in the five counties and sixteen cities of the Ozark Foothills Region of Missouri.

The foundation's eleven-member Board of Governors is led by Mr. Russell French, Chairman; Dr. Scott Dill, Secretary; and, Mrs. Crystal Jones, Treasurer.

As of June 2021, the foundation held funds with total assets valued at \$1,342,700.



# Ozark Foothills Solid Waste Management District

The Ozark Foothills Solid Waste Management District, Region Q, in partnership with the Missouri Department of Natural Resources funds the Ozark Foothills Materials Recovery Facility (Recycling Center).

In doing so it provides region-wide recycling services to Butler, Carter, Reynolds, Ripley and Wayne Counties.



## **Ripley County Public Housing Agency**


The Ripley County Public Housing Agency is authorized to provide HUD Section 8 rental and, if applicable, utility subsidies to 441 families throughout the five-county service area.

As of June 30, 2021, 33 families were enrolled in the agency's Family Self-Sufficiency and Homeownership Programs, while 411 families were receiving Section 8 rental assistance.

### Ripley County Public Housing Agency FY 2021 Goal Progress

#### **Accomplishments**

- Number of Vouchers Filled Increased from 299 on July 1, 2008 to 411 on June 30, 2020, exceeding goal by 1. 40 additional mainstream vouchers were added in January 2021.
- ✓ Monthly Administrative Fee Eligibility Averaged \$22,541 per month while average expenses totaled \$22,765 per month
- Family Self-Sufficiency Caseload decreased from 33 Families on June 30, 2020 to 32 Families on June 30, 2021. The Minimum Caseload Requirement Remained Unchanged at 25 Families.
- ✓ Annual SEMAP Review was not conducted by HUD due to COVID; however, internal quality control inspections were completed by 9/1/21.

# Ozark Foothills Transportation Advisory Committee

The Ozark Foothills Transportation Advisory Committee (TAC) consists of twenty-five members who meet quarterly to identify, discuss, and prioritize the region's transportation needs.

Prioritized needs are relayed to MODOT for potential inclusion within the five-year Statewide Transportation Improvement Program, or STIP, which is updated annually.
