

The Ozark Foothills Regional Planning Commission (OFRPC) manages its internal activities, as well as the activities of the Ozark Foothills Development Association, the Ozark Foothills Regional Community Foundation, the Ozark Foothills Solid Waste Management District, and the Ripley County Public Housing Agency.

The OFRPC's core service is providing grant preparation and administrative services to its five member counties & sixteen member cities.

During Fiscal Year 2022, OFRPC staff prepared 55 grant applications and brought **\$6,873,774** into the Ozark Foothills Region.

Ozark Foothills Development Association, Inc.

The Ozark Foothills Development Association is an IRS-defined non-profit charged with enhancing economic development in the five-county region. The association administers the Ozark Foothills Business Incubator.

The Small Business Incubator, constructed in 1988 and expanded in 2018, provides 30,000 square feet of affordable operating space to start-up or expanding enterprises.

During FY 2022, the Ozark Foothills Development Association maintained 100% occupancy within its original incubator and 100% within the expansion area.

The last of the four newly constructed spaces was rented in September 2021.

Ozark Foothills Regional Community Foundation

The Ozark Foothills Regional Community Foundation, established November 2011, is the charitable arm of the Ozark Foothills Regional Planning Commission.

The mission of the Foundation is to establish endowments that enhance the quality of life for current and future generations by reinvesting in the five counties and sixteen cities of the Ozark Foothills Region of Missouri.

The foundation's eleven-member Board of Governors is led by Mr. Russell French, Chairman; Dr. Scott Dill, Secretary; and, Mrs. Crystal Jones, Treasurer (through April 2022), Treasurer position currently vacant.

As of June 2022, the foundation held funds with total assets valued at \$2,014,413.



Ozark Foothills Solid Waste Management District

The Ozark Foothills Solid Waste Management District, Region Q, in partnership with the Missouri Department of Natural Resources funds the Ozark Foothills Materials Recovery Facility (Recycling Center).

In doing so it provides region-wide recycling services to Butler, Carter, Reynolds, Ripley and Wayne Counties.



Ripley County Public Housing Agency


The Ripley County Public Housing Agency is authorized to provide HUD Section 8 rental and, if applicable, utility subsidies to 461 families throughout the five-county service area.

As of June 30, 2022, 37 families were enrolled in the agency's Family Self-Sufficiency and Homeownership Programs, while 432 families were receiving Section 8 rental assistance.

Conduct an Internal Program Review

Accomplishments

- Number of Vouchers Filled Increased from 299 on July 1, 2008, to 411 on June 30, 2020, exceeding goal by 29. We were able to add 40 additional mainstream vouchers in January 2021.
- Monthly Administrative Fee Eligibility Averaged \$25,524 per month while average expenses totaled \$20,054 per month
- ✓ Family Self-Sufficiency Caseload decreased from 32 Families on June 30, 2021, to 26 Families on June 30, 2022. The Minimum Caseload Requirement Remained Unchanged at 25 Families.
- Annual SEMAP Review was required by HUD this year and we completed it during June 2022, along with the internal quality control inspections.

Ozark Foothills Transportation Advisory Committee

The Ozark Foothills Transportation Advisory Committee (TAC) consists of twenty-five members who meet quarterly to identify, discuss, and prioritize the region's transportation needs.

Prioritized needs are relayed to MODOT for potential inclusion within the five-year Statewide Transportation Improvement Program, or STIP, which is updated annually.

- 3. <u>Safety Shoulders on Highway 49 from Highway 67 to Mill Spring</u> and Piedmont to Iron County line and widen existing box culverts in <u>Wayne County.</u>
- 4. Low water crossing on Highway K between CR K-5 and CR K-6 in Ripley County.
- 5. Overlay and add shoulders to D Highway in Carter County.
